# Safeguarding News From Chile



In 2015, on the feast of Our Lady of Mount Carmel, guidelines from the Bishops' Conference was promulgated and decreed for each Diocese. At this time basic courses on *Prevention of Abuse of Minors & Vulnerable People*, were provided. In May, 43 people of our parish of San Matias in Santiago, attended the course. The general body of people coming to Church tend to be passive, with work and economic factors taking precedence and it takes a lot of motivation to become active agents in prevention of abuse. We are very happy that the pastoral agents of the parish took time to attend the course. There is a lot of awareness now in Chilean society about abuse. The anger towards the Church among the people is especially towards the hierarchy for having covered up abuse perpetrated by the clergy.

I will finish by saying that the Church in Chile has advanced greatly in the area of prevention and dealing with abuse especially at administration and the chancellery level. This will be in time a big contribution to Chilean society which is in crisis and needs to grow in respectful relationships, trust and confidence.

We, Columbans are obliged to follow the Diocesan Guidelines, those who do the course are credited and registered in the Diocese. The Columbans in Peru & Chile under the Director Tony Coney will be continuing with the theme of protection in coming assemblies.

## Update on Revision of Safeguarding Children, Policy and Standards for Catholic Church in Ireland (2016)

A draft is to be submitted to the Irish Catholic Bishops Conference (IEC) and The Association of Leaders of Missionaries and Religious of Ireland (AMRI) by the end of May/June. Further consultation if approved by IEC and AMRI – June, July and August. Consideration of further amendments – September 2023. The National Board are considering the new policy to have three areas:



- Prevention: Standards 1,5 and 6
- Intervention: Standards 2,3 and 4
- ► Governance: Standards 7

# Scoping Inquiry into Schools run by

## **Religious Orders**


In the aftermath of revelations made regarding abuse of minors in schools run by the Spiritans, Carmelites and Jesuits, on 7th March Norma Foley, the Minister of Education, announced the setting up of a 'scoping inquiry' into allegations of historical sexual abuse at schools run by religious orders.

In response to this Padraig McCarthy, a retired diocesan priest, wrote in a letter to the Irish Times on 13th March 2023:

'This is a step in the right direction. Any abuse, even just one case is abhorrent. The Inquiry announced is, however, a highly discriminatory step. Religious orders are not the only organisations which provide such educational services. Is the Minister suggesting that those others are immune from such abuse, including schools run by the State itself? Studies of abuse in U.S. public schools also indicate serious levels of abuse. Why restrict the scoping inquiry to schools run by religious orders, if we are serious about discovering the full facts?

It is of further concern that religious orders are characteristic of the Catholic church. To restrict the inquiry just to Catholic organisations would seem to suggest that the Catholic church is inherently more to be mistrusted than other organisations.'

Justine McCarthy, writing in the Irish Times on April 14th under the headline "Sectarian criteria undermines abuse inquiry before it begins", expanded on what Padraig McCarthy wrote with regard to the discriminatory nature of the scoping exercise.



If we journey together, young and old, we can be firmly rooted in the present, and from here, revisit the past and look to the future. To revisit the past in order to learn from history and heal old wounds that at times still trouble us.

To look to the future in order to nourish our enthusiasm, cause dreams to emerge, awaken prophecies and enable hope to blossom. Together, we can learn from one another, warm hearts, inspire minds with the light of the Gospel, and lend new strength to our hands.
